### **DECISION**

Pursuant to Article 11 section 4 of the Act dated 27<sup>th</sup> July 2005 – Law of Higher Education (Journal of Laws/ Dz.U. 2017 item 2183, as amended thereafter) in relation to Article 205 section 2, Article 192 section 2 of the Act dated 3<sup>rd</sup> July 2018 – Provisions introducing the Act - Law of Higher Education and Science (Journal of Laws/ Dz.U. 2018 item 1669) and Article 104 § 1 of the Act dated 14<sup>th</sup> June 1960 – Code of Administrative Procedure (Journal of Laws/ Dz.U. 2018 item 2096, as amended thereafter) (hereinafter referred to as Code of Administrative Procedure), having considered the request of Collegium Humanum Szkoła Główna Menedżerska (Collegium Humanum Warsaw Management University) dated 24<sup>th</sup> September 2018 and obtained the opinion of Polish Accreditation Committee expressed in Resolution no. 14/2019 dated 24<sup>th</sup> January 2019,

**I hereby grant to:**

**Collegium Humanum Szkoła Główna Menedżerska (Collegium Humanum Warsaw Management University)**

**the authorization to offer unified university Master level studies with practical profile  
in the field of “Psychology”**

in accordance with the description of the effects of education for this field of university studies, the education level and profile defined by the Senate of Collegium Humanum Szkoła Główna Menedżerska (Collegium Humanum Warsaw Management University) in Resolution no. 01/11/18 dated 7<sup>th</sup> November 2018.

### **JUSTIFICATION**

Pursuant to Article 107 § 4 of the Code of Administrative Procedure, this decision shall not be justified owing to the fact that it meets the party's demand in full.

### **Instruction**

One is not entitled to appeal against this decision. However, a party who is dissatisfied with the resolution may turn to the Minister of Science and Higher Education, pursuant to Article 127 § 3 of the Code of Administrative Procedure, with a request for reconsideration of the matter, within 14 days of the service hereof.



Pursuant to Article 127a of the Code of Administrative Procedure during the course of the period in which one may ask for reconsideration of the matter, one may waive their right to submit such a request. As of the date on which the Minister of Science and Higher Education is served a statement of waiver of the right to ask for reconsideration of the matter, the decision becomes final and legally valid.

Within 30 days of the service hereof a party may submit a complaint to the Provincial Administrative Court in Warsaw through the Minister of Science and Higher Education without exercising the right to request reconsideration of the matter.

The cost of a permanent entry regarding a complaint in this case is PLN 200.

At the same time, please be informed that pursuant to Article 243 § 1 and Article 244 § 1 of the Act dated 30<sup>th</sup> August 2002 – Law of proceedings before administrative courts (Journal of Laws/Dz.U. 2018 item 1302 as amended thereafter), the right to assistance can be granted to a party at the party's request submitted before instigation of proceedings or in the course of the proceedings. This request is free from any court fees. The right to assistance entails exemption from the court fees and appointment of an attorney-at-law, legal counsel. Detailed principles of the right to assistance are regulated by the provisions included in Articles 243-262 of the Act - Law of proceedings before administrative courts.
