DECISION

Based on Article 57 section 1 and 54 section 2 point 1 and section 3 of the Act of 20 July 2018 – Law on higher education and science (Journal of Laws of 2020, item 85), in connection with Article 206 section 1 point 2 of the Act of 3 July 2018 – Regulations introducing the Act – Law on higher education and science (Journal of Laws of 2018, item 1669, as amended) and Article 104 section 1 of the Act of 14 June 1960 – Code of Administrative Procedure (Journal of Laws of 2020, item 256, as amended), hereinafter referred to as ‘CAP’, after examining the application of Collegium Humanum – Warsaw Management University with headquarters in Warsaw to grant permission to create Bachelor’s and Master’s Degree studies of “pedagogy” to be run at the University Branch in Rzeszów, and after consulting the Polish Accreditation Commission expressed in Resolution No. 315/2020 of 18 June 2020,

I hereby grant permission to
Collegium Humanum – Warsaw Management University with headquarters in Warsaw
to create Bachelor’s and Master’s Degree studies
with a practical profile
in the field of “*pedagogy*”
to be run at the University Branch in Rzeszów.

Substantiation

Based on Article 107 section 4 of the Code of Administrative Procedure, the reasoning of the decision was waived because it fully takes into account the party's request.

Instruction

There is no appeal against this decision. However, the party which is dissatisfied with the decision may apply to the Minister of Science and Higher Education, pursuant to Article 127 section 3 of the Code of Administrative Procedure, with a request for reconsideration of the case within 14 days from the date of delivery of this decision.

Based on Article 127a of the Code of Administrative Procedure, during the time limit of the application for reconsideration of the case, the party thereof may waive its right to submit the request in question. On the day of delivering to the Minister of Science and Higher Education a statement of the waiver of the right to submit a request for re-examination of the case hereto, the decision becomes final.

Within 30 days of the delivery of this decision, the party in question may submit through the Minister of Science and Higher Education a complaint to the Regional Administrative Court in Warsaw, without exercising its right to lodge an application to reconsider the case. In the present case, the fixed fee for lodging the complaint is PLN 200 in accordance with Article 2 section 1 point 2 of the Regulation of the Council of Ministers of 16 December 2003 on the amount and detailed rules for collecting fees in proceedings before administrative courts (Journal of Laws No. 221, item 2193, as amended).

At the same time I hereby inform that pursuant to Article 243 section 1 and Article 244 section 1 of the Act of 30 August 2002 – Law on proceedings before administrative courts (Journal of Laws of 2019, item 2325, as amended), hereinafter “Ppsa”, the right of assistance may be granted to a party upon its request submitted before the initiation of the proceedings or during the proceedings. This application is free of court fees. The right to assistance includes an exemption from court fees and the appointment of an advocate, an attorney-at-law. Detailed rules on the right to assistance are governed by the provisions of Articles 243–262 of the Ppsa.
